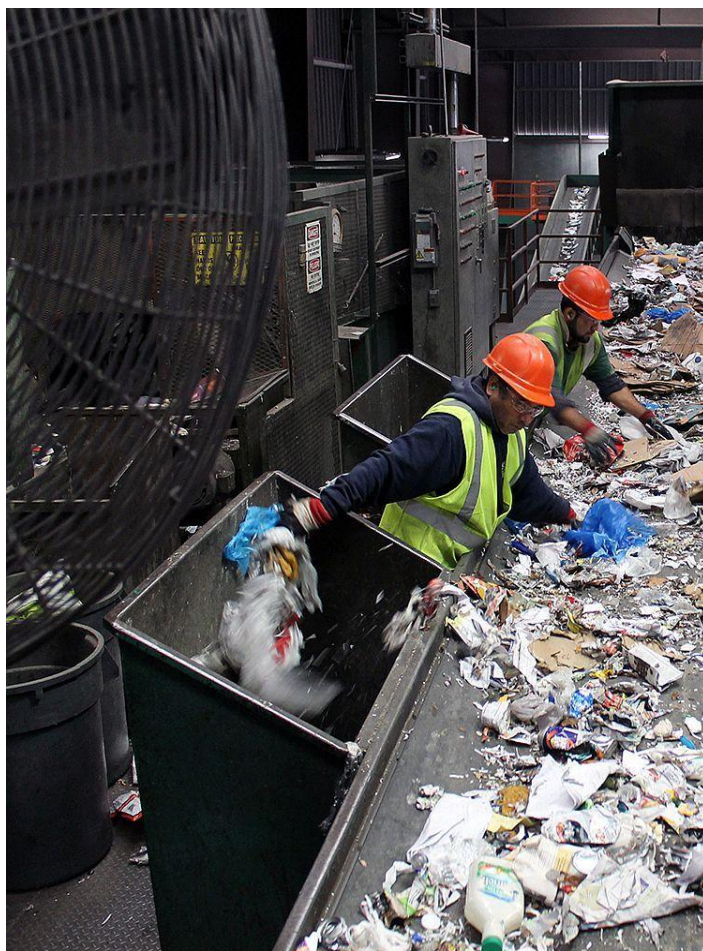

REGLEMENT DE PARTICIPATION

ARTICLE 1 : SUBSCRIPTION

The participation form must be completed and sent to the organizer by fax at : +213 (0)21 96 70 70 / +213(0)23 79 50 43 or by e-mail to: info@revade.dz

- The signature of the participation form means that the company wishing to exhibit accepts all the clauses of the present regulations and any new provisions that may be imposed by the circumstances. The organization of the exhibition, including opening and closing dates, venue, prices and authorized public are determined by the organizer and may be modified at his initiative.
- The organizer can cancel or postpone the exhibition in the case of insufficient number of exhibitors. The exhibitor then sees restoring the amount of his participation.
- In case, for major reasons such as fire, flood, destruction, accident, strike, riot, risk of insecurity, threat, or other cases of absolute necessity, the exhibition can be postponed or canceled. The exhibitor is then returned the amount of his participation.

ARTICLE 2 : CONDITIONS OF PARTICIPATION

The participation forms must be sent to the Algerian Chamber of Commerce and Industry duly completed and signed by the exhibitor or the person authorized to enter it.

- On receipt of the **PROFORMA** invoice, the exhibitor to pay the full amount of his participation.
- It is forbidden for the exhibitors to sell all or part of their booth.
- In case of cancellation by the exhibitor of his participation, the sums paid remain acquired by the organizer.

ARTICLE 3 : CANCELLATION

- In case of cancellation of participation for any reason, the sums paid are acquired to the organizer even if another exhibitor comes to benefit from the exhibition space.
- In case the exhibitor, for any reason, does not occupy his booth 24 hours before the opening of the exhibition, he is considered to have resigned.
- The organizer may freely dispose of the exhibition space of the defaulting exhibitor without the exhibitor being able to claim any refund or compensation and remove any visuals relating to the products of the defaulting exhibitor.

ARTICLE 4 : PRICE AND PAYMENT

The organizer sets the prices for participation in the exhibition.

- The payment of the participation and other expenses is made according to the deadlines and according to the modalities determined by the organizer.

ARTICLE 5 : ASSIGNMENT OF BOOTHS, SECURITY

The organizer establishes the plan of the exhibition and distributes the locations, taking into account, if possible, the wishes of the exhibitor, the nature of the products and / or services it presents, the layout of the space of exhibition to be installed and the date of registration of the request to participate.

- The minimum surface allocated is **6 m²**
- The locations are available to the exhibitors, naked four (04) days before the opening of the event.
- Electrical installations must be in accordance with all safety conditions. In case of defects in the electrical installation, the supply of power will be suspended until these defects are remedied.
- Rental amount of locations is calculated per full square meter. Each square meter, even if it is not fully occupied, counts for one square meter occupied.
- All locations attributed by the organizer must be paid in full even if they are not fully occupied.

ARTICLE 6 : ASSEMBLY AND DISMANTLING

The organizer determines the schedule for assembling and dismantling of the booths.

- The products and materials exhibited can't, under any pretext whatsoever, leave during its duration.

ARTICLE 7 : CLEANING AND GUARDING

- The cleaning of booths during the show is the responsibility of the exhibitor.
- The guarding of the pavilion and the booths is chargeable to the exhibitor.

ARTICLE 8 : INSURANCE

- **SAFEX** supports the insurance of paths, passages, pavilion and infrastructures in civil liability.
- Exhibitors have to insure themselves the installations of their booths, any exhibited material, against fire, theft with or without burglary and liability.

ARTICLE 9 : CATALOG

The size of the catalog is determined by the organizer.

- The exhibitor guarantees that the information provided by him (company name, address, activity, contact, ...) for publication in the exhibition catalog.
- Advertising inserts must be sent to the organizer in digital format and at high resolution (**JPEG- PDF- PSD- AI- TIF**) 10 days maximum before the exhibition.
- Exceeding this deadline, the organizer is not responsible for the insertion of the advertisement on the catalog

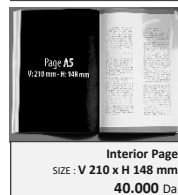

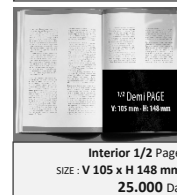

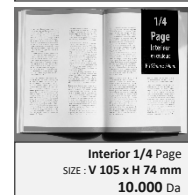
